Terms & Conditions of Sompo Private Car Insurance for GrabHitch Offer ("Offer")

1. The Offer is jointly organised by GrabCar Pte Ltd ("Grab") and Sompo Insurance Singapore Pte Ltd ("Sompo") with the promotion period ("Promotion Period"): 22 January to 21 April 2018, both dates inclusive.
2. The motor insurance product under this Offer is Sompo Private Car Insurance (the "Product").
3. The Offer is a S\$50 cash rebate to be given by Grab to a Qualifying Driver upon his/her successful purchase of a Product from Sompo.
4. Only Qualifying Drivers are eligible for the Offer. To be a "Qualifying Driver":
 - a. you must be an approved GrabHitch Driver prior to the purchase of a Product from Sompo;
 - b. you are not an existing Sompo private motor policyholder;
 - c. your new motor insurance sign up must be transacted online at www.Sompo.com.sg during the Promotional Period with the promo code "HITCH18" and the application must be accepted by Sompo and the premium fully paid to Sompo;
 - d. the commencement date of your motor insurance policy mentioned at (c) above ("Policy") must be within 60 days from the date of purchase; and

Thereafter, please wait until the end of the month and allow up to 10 working days for the processing to be completed, and for the S\$50 credit to be disbursed by Grab to your driver wallet. The S\$50 credit will be clawed back should you cancel your purchased Policy within 60 days of the Policy commencement date.
