"#GRABFOODIE" CONTEST (the "Contest")

Campaign period: 30 May 2018 to 30 June 2018

Terms & Conditions

Phase 1 (30 May 2018 to 20 June 2018)

- Contest entry requirements:
 - 1) *Take a food photo*
 - 2) *Write a caption*
 - 3) *Tag @GrabFoodSG and #GrabFoodie*
 - 4) *Post this up on your Instagram or Facebook page, set to public view.*
- Only entries fulfilling all of the above requirements, and posted up before 20 June 2018, 11.59pm will count as a contest entry submission.
- Participants can post as many entries as they wish to increase their chances of being shortlisted as our top 25 participants.
- By fulfilling all contest entry requirements / participating in this contest, you are providing consent to Grab to re-post your entry content for marketing communications purposes.

Phase 2 (21 June 2018 to 25 June 2018)

- A panel of judges from Grab will shortlist 25 participants based on who fulfills the below criteria best:
 - 1) *Aesthetics of photo image*
 - 2) *Creativity of content, pertaining to both subject matter in photo image and accompanying post caption*
- Judges' decision on who the 25 shortlisted participants are is final and no correspondence will be entertained.
- Grab will contact the 25 shortlisted participants to participate in the Final Showdown Event ("Event") where they will compete against each other for the SGD \$10,000 Grand Prize ("Prize").
- Date and timing of the Event will be finalized before 21 June 2018, and will be conveyed directly to the 25 shortlisted participants.
- Shortlisted spots are non-transferable.

Phase 3 (26 June 2018 to 30 June 2018)

- The Event will take place on a date falling between 26 June 2018 to 30 June 2018.
- At the Event, the 25 shortlisted participants are required to participate in up to 3 challenges whereby a Prize winner will then be selected.
- The 3 challenges are to be determined by Grab and are subject to changes.
- If you are one of the 25 shortlisted participants, you hereby consent to the use by Grab and its affiliated companies for an unlimited time, your image, photograph, video (if applicable) for publicity purposes (in any medium), and in advertising, marketing on promotional material without additional compensation or prior notice and, in participating in this Contest, all participants consent to the same.
- Judges will determine who wins the Prize, and their decision is final and no correspondence will be entertained. The Prize winner will receive confirmation that he / she has won the Prize either in person or via e-mail and by phone (providing a contact number has been provided) within fourteen days from the Event.

The Winner

- The total Prize sum of SGD \$10,000 will be awarded to the winner over a 12-month period starting from the date of confirmation that he / she has won the Prize. The sum of SGD \$830 will be awarded every month for a total duration of 11-months, with the exception of the 1st month where the winner will be awarded the amount of SGD \$870.
- The monthly Prize sum amount will be awarded to the winner via GrabPay Credits. A GrabReward will be issued to the winner's registered Grab account, and the winner will need to redeem the GrabReward to credit the amount into his / her GrabPay Credits Wallet.

- GrabPay Credits Wallet has a maximum limit of SGD \$999. The winner will need to ensure that his / her wallet balance will not exceed the maximum limit when he / she redeems the GrabReward.
